RE: FORMER KEW COTTAGES (KEW RESIDENTIAL SERVICES) PRINCESS STREET KEW H2073 – HERITAGE PERMIT P15474

I advise that in response to submissions received in relation to the recent Heritage Permit application, the applicants have advised that it is withdrawing that part of the application relating to the three buildings in the historic core, and the proposed sports building, and associated works, leaving only the 12 lot subdivision to be considered at this stage.

The 12 lot subdivision proposal has been slightly revised, (Lot 136) and I enclose for your information a copy of the revised additional drawings which, together with the originally submitted elevations, form the basis of the current Heritage Permit application P15474.

The proposals in relation to the historic core will be the subject of a fresh Heritage Permit application in due course.
